### **REPORT TO BOARD FROM REV. CLARE**

December 15, 2023 Since my last report...

### WORSHIP

November 12 we celebrated Diwali. One expectation of the holiday is giving the gift of generosity. Kara Tyler taught us a dance! SarahRuth delivered the meditation! The Choir sang! It was a joyful worship service!

November 19 we explored what the Buddha taught about generosity. The Community Choir offered their gift of music. Mia Hager lighted our chalice. Edith Roundy led us in meditation for the Time for All Ages. Henry Gieszl and Mia Hager worked on hospitality. Our Youth Group and Community Choir were the perfect illustration of what the Buddha taught about generosity!

November 26 we are all grateful to Dominique Hall for stepping in for Tracey Myers Preston who crafted a beautiful worship service on hospitality and connection (and who was prepared to deliver it with her children) before falling ill. Thank you, Tracey! Thank you, Dominique!

December 3 we began exploring the gift of mystery with a closer look at what the proposed Article II revision of the UUA Bylaws has to say about direct experience of transcending mystery and wonder. ### Appendix 4: Treasurer's Report

#### End of November 2023

As of the end of November, our endowment account had \$ 1,161,868.78. This is up \$96,631.00 (9.0%) from the end of October. The total cash in the endowment fund as of the end of November was \$ 31,156.13 (3%) in cash and \$ 79,898.924 (7%) in bonds.

As of the end of November the money in our checking, PNC money market, and Schwab money market accounts totaled \$119,110. This includes the money in reserved accounts. This is down around \$11,000 from the amount at the end of October. This does not include the \$153,005.87 that we received from the Bolz bequest.

As of the end of November we have \$5700 in the building fund (according to Arkady).
